CONDITIONS OF PERMIT

If your venue is within the Warehouse District or the 6th Street District:

Your outdoor music venue may use sound equipment at an outdoor music venue with an occupancy capacity of 600 or fewer people located in the Warehouse District or the 6th Street District that produces sounds as measured at any point along the property line of the permitted venue not greater than 85 decibels; restaurants with 51% food sales not greater than 70 decibels between 10:00 a.m. and 2:00 a.m.

If your venue is located outside both districts:

Your outdoor music venue may use sound equipment that produces sound as measured at any point along the property line of the permitted venue not greater than 85 decibels; restaurants with 51% food sales not greater than 70 decibels between 10:00 a.m. and,

1. 10:30 p.m. on Sunday through Wednesday,
2. 11:00 p.m. on Thursday, or
3. 12:00 midnight on Friday or Saturday

Additional conditions for all outdoor venues:

The permit issued for this venue expires at midnight on the first anniversary of the date on which the permit is issued. It is the applicant's responsibility to renew the permit in a timely fashion.

The Accountable Official may refuse to issue an outdoor venue permit if the permittee is convicted of more than two violations of a permit issued under Chapter 9-2, or if the property where the sound equipment will be used is the location of more than two violations of a permit issued under Chapter 9-2.
