The agency must fill out the program name, description, and general program type as well as the date the Threshold Review is submitted. Don't leave fields blank – just put NA if not applicable.   |
| 2               | To confirm both the housing stability case management & financial assistance are required budget activities. Correct?                                   | Yes these are two core activities in a Prevention program.   |
| 3               | Is it permissible to move clients include a unit with a master lease (under the name of the agency) because the client cannot get a lease on their own? | It is allowable. However, the program must allow participants to choose housing options that the participant is interested in.  There are additional Conflict of Interest requirements which must be completed regarding any financial assistance provided on behalf of the participant to the unit the agency owns. Rental Assistance cannot be provided to properties which the applicant owns or financially benefits from unless a third party determines that the rent established in the lease is reasonable, completes the habitability assessment, and approves the amount of rental assistance provided by the project. The third party would need to be an entity which does not have a financial benefit from the rental costs being assessed. For example, the recipient could contract with an other entity to complete the rent responsibility and habitability, but that entity wouldn't benefit from the rental payment made on behalf of those assessments. |

| 5 | Kind of a specific case, but I'm curious about the following scenario: could we help eligible households secure vouchers (e.g., FUP vouchers for households with current CPS involvement) and provide case management using these funds, provided households meet this RFA's eligibility criteria around risk of homelessness? | If the household meets both the eligibility criteria (At Risk of Homelessness and/or At Imminent Risk of Homelessness) at eligibility determination and meets your developed criteria for appropriateness, then the household could be enrolled in services. If you were to establish voucher eligibility as an additional eligibility criterion for the project, that would need to be identified within your application. |
| 6 | If we have gotten a Threshold<br>Review approved by APH, does<br>that count toward our eligibility<br>to apply for this RFA?   | Yes. If an agency has submitted a threshold review in the last 12 months in Partnergrants, HSO is working with APH in review of these applications, and you will not have to resubmit.  |
| 7 | Does the eligible financial assistance under this RFA include mortgage payments for households at risk of homelessness, or is assistance limited to rental payments only?  | The Scope of Work only allows rental assistance and excludes mortgage payment assistance.   |
| 8 | How do we apply for a collaboration?   | The collaboration will need to designate a Lead agency who will submit the application. The collaborative agencies will fill out budget subgrantee forms and their information, program design, etc. will need to be included throughout the application.   |
| 9 | If we have a subcontractor that is serving youth exiting foster care can we use this funding to prevent homelessness?  | Yes. If a youth engaged in the foster case system met the eligibility criteria of this project (At Risk of Homelessness or At Imminent Risk of Homelessness) and was determined appropriate for your project based on your assessment criteria, the client could be served by the project.  |

The third party would need to be an entity which does not have a financial benefit from the rental costs being assessed.
