## **EFFECTIVE MAY 26, 2015**

Due to the approval by the Texas Legislation Senate Bill 582:

- Food Handlers are *no longer required* to register with the City of Austin.
- EHSD no longer accepts applications for Food Handler Registration.

### Training is still required for ALL food handlers

- Food Handler training accredited by the TX DSHS and /or
- American National Standards Institute (ANSI) Certified courses are approved.
