


# Fight the Bite Day and Night with the Four Ds:

- Dusk and dawn: Although different species of mosquitos are active at different times of day, the species that spread West Nile Virus are most active between dusk and dawn.
- Dress: Wear pants and long sleeves when you are outside. Wear light-colored, loose-fitting clothing; mosquito repellent clothing is also available.
- DEET: Apply insect repellent that contains DEET. Read and follow label instructions. Spray both exposed skin and clothing with repellent.
- Drain: Get rid of standing water in your yard and neighborhood. Old tires, flowerpots, clogged rain gutters, birdbaths and wading pools can be breeding sites for mosquitos.

To report a mosquito problem, call 3-1-1 or complete a Service Request online.

APH is seeing an increase in mosquito activity in the Austin/Travis County area with several traps testing positive for West Nile Virus this season. There has been 1 confirmed human case reported by the state.



Mosquitoes are present in Central Texas yearround, but the population is largest and most active from May through November. During this period, Austin Public Health monitors the population and tests for mosquito-borne viruses. Those that carry West Nile Virus (WNV) are of particular concern.

## New Food Manager Registration Updates:

Due to the passage of **Senate Bill 577**, local health departments will <u>no longer</u> <u>require registration</u> of food manager certificates. Effective 9/1/2023, Environmental Health Services will not accept applications for food manager registrations. Per 2017 FDA Food Code 2–101 and 2–102, continue to display a state Certified Food Protection Manager Certificate in a prominent location. A Person–In–Charge must be present during all hours of operation and must have a certified food manager from s state approved course.




# **Off Season To Do List For Pool Operators**

It is that time of year for kids of all ages begin to go back to school and work. Pool operators may feel that they get a break too because the pool on their property does not need as much attention after the summer months are over. This is not entirely true; a pool is required to be properly maintained throughout the entire year.

Some items to think about during the off season:

- ★ Make sure you walk your pool fence enclosure to inspect for any opening greater than 4 inches, such as missing pickets or erosion of the ground beneath the fence
- ★ Make sure your fence gates self-close and self-latch
- ★ Make sure your pool chemistry is within proper range and you can see the drains at the bottom
- ★ Make sure your safety equipment is present and in good condition for future use



Extended closures of hot tubs/spas could create conditions favorable to *Legionella* and other bacterial growth in the hot tub/spa if:

They are in a public aquatic facility that will be closed for weeks or months, and

A qualified operator is unable to maintain water quality during the closure. Check for existing regulations and guidelines from your local or state regulatory agency before using these recommendations. They do not replace:

- Existing regulations or guidelines from your local or state regulatory agency or
- ★ Consultation with a service company or the company or engineer that designed the aquatic facility.

### It's time for your flu shot!



Influenza (flu) is a very contagious respiratory illness that affects millions of people every flu season. Most people will have mild illness, but some cases can result in hospitalization or even death. Children and people 65 years and older are more likely to get sick from the flu. While people with asthma, diabetes heart disease and those who are pregnant are at higher risk of flu complications, getting an annual flu vaccine is the best way to protect our community and our loved ones from the flu.

#### Flu Symptoms:

- Fever or chills
- Cough, sore throat
- Runny or congested nose
- Muscle or body aches
- Headache
- Fatigue
- Some people may have vomiting and diarrhea– this is more common in children

#### **Flu Vaccination**

The Centers for Disease Control and Prevention (CDC) recommends that anyone six months of age and older should be vaccinated for the flu every flu season. High-risk individuals include:

- Adults 65 years and older Children younger than 5 years
- Pregnant women
- People with chronic medical conditions
- Health care workers
- Individuals who live with an/or care for high-risk individuals

#### Where to Get Vaccinated

Flu shots are available at <u>Shots for Tots/Big Shots</u> clinics for children who are uninsured or Medicaid recipients, and for uninsured adults. Cost of the flu vaccine is \$25 for adults, \$10 for children, and free for children with Medicaid. For an appointment, please call **512-972-5520**.

#### **Additional Flu Prevention**

In addition to getting the flu shot, take these actions to prevent the flu:

- Avoid others who are sick
- Wash your hands often with soap and water, or use an alcohol-based hand sanitizer if soap is unavailable
- Cough and sneeze into your sleeve or into a tissue
- Avoid touching your nose, mouth, and eyes
- Stay home if you are sick
- Clean and disinfect surfaces that may be contaminated with flu
