- 1. Would individuals with VA (Veteran) Health Care to be eligible?
 - **A.** As referenced in Section 0500 Scope of Work, Section 6 Outputs & Outcomes, 100% of all individuals served must be uninsured or utilize Medicaid. *Please note:* This answer is different than the response given during the Pre-bid Meeting on 9/11/14.
- **2.** You said "moved into unit" for chronically homeless- could that be community entry not unit? (ex: moved into 201, but was accommodated and moved to 101 still eligible?
 - A. Yes
- **3.** Why only 30% in first year of budget?
 - **A.** The 3 budget period percentages outlined in Section 0600 Proposal Preparation Instruction & Evaluation Factors; Part II Cost Effectiveness; Section A Budget, is the framework for funding based on the performance expectations of this funding announcement. Applicants are expected to adhere to these percentages when developing their budget unless justification is given to support different allocations per budget period.
- **4.** Should the 3rd period ending date be 2017 instead of 2015?
 - **A.** In Section 0600 Proposal Preparation Instruction & Evaluation Factors; Part II Cost Effectiveness; Section A Budget, the ending date for the third budget period listed should be March 31, 2017.
- **5.** Section 0800, 0805 & 0810 have an asterisk (no pages) are those not included in this solicitation?
 - **A.** Documents listed in the table of contents which are marked with an asterisk (*) are incorporated into this Solicitation by reference, with the same force and effect as if they were incorporated in full text. - **6.** Do clients served have to be Medicaid eligible?
 - **A.** Please see response to Question #1.
- **7.** For Healthy Service environment bonus, does tobacco free campus bonus apply to tenants in PSH as well?
 - A. Yes
- **8.** Does the person submitting the application need to have a valid ID? That wasn't noted on the last solicitation, but was required.
 - A. No
- **9.** May an agency apply to provide one component of ACT Team services rather than comprehensive wraparound services?

- **A.** Yes, an agency may apply to provide one component of ACT Team services but the other components of ACT Team services must be available to clients who receive services funded through this solicitation.
- **10.** Is there a <u>minimum</u> number of individuals to be served by each component of ACT Team?
 - **A.** No, although, as referenced in Section 0500 Scope of Work; Section 4 Program Strategies, the successful applicants will provide case management staff ratios of 1:10 or less for individuals.
- **11.** Is there a preferred ratio for services other than case manager?
 - A. No.
- **12.** If several agencies qualify as eligible applicants per page 7 of Section 0500 and want to form an ACT Team, how should the lead applicant be determined?
 - **A.** The agencies should determine the lead applicant.
- **13.** Could I use this money to add a missing component to my service menu that will increase ability to meet the outcomes required, even though I don't describe my service model as an ACT Team?
 - **A.** Yes, an agency can apply for funding of a component of an ACT Team if the agency has the other components already in place with other funding.
- **14.** Reference for what constitutes an ACT team. Fidelity?
 - **A.** See Section 0500 Scope of Work, Section 2 Background, page 2 of 7.
- **15.** I know there would be a benefit for services being on-site in a community. Is that being considered in the evaluation/scoring of this solicitation?
 - **A.** No evaluation preference is outlined in this solicitation for services being available to clients on-site in a community.
- **16.** In the budget, do we need to include for training for the assessment we will use or is that something the City of Austin is covering?
 - **A.** The City of Austin will cover any training necessary for administering the required assessment.
