6	We tried to register in Partnergrants but got an email saying it had been rejected due to the vendor ID not being in the system.	When you submit a request for a Vendor number, APH staff reviews the Finance Online for the information about your organization. There may be a lag between the time you submit a request for a Vendor ID and the time that it gets approved and active. APH staff can not approve a registration in Partnergrants unless it can be verified on Finance Online.
7	Our HR Director stated that we do not meet the insurance requirements, does that mean we are disqualified from the competition?	If your organization does not meet the insurance requirements at this time, you can develop them before the execution of the contract if you are chosen for award. However, if your HR Director does not think that your organization will be able to meet those requirements, then we would not be able to contract with your organization.
8	Curious if a subgrantee can be on more than one proposal – Appreciate any clarity you can provide on how many RFAs can an organization can be a part of	Yes your organization can be involved in more than one proposal.
9	Regarding the requirement for 2 years of experience – if we do not have that full two years of experience, will this disqualify us?	Agencies are asked to demonstrate the two years of providing services and there are a number of questions regarding your agency's experience. It is not a threshold question, so if you would like to submit an application, your agency's experience will be considered and scored by the evaluation team. So, in short, no your organization is not disqualified, but the experience will be evaluated in that experience section. Please see the scope of work Section IV. Evaluation Factors for more information.
