We are imagining that the exact placement of the new drinking fountains will be determined after considering the location of water lines. We anticipate that this means the new fountains would be located near the north wall of the school building. They might be near the entrance from the Slayton Dr. parking lot, midway the building near the bleachers, or closer to the northwest corner.
