I hereby enter a plea of “no contest” to the violation of \_\_\_\_\_ and waive my right to trial. I request the Court allow me to complete a Deferred Disposition for this case. I understand if I successfully complete the terms of the Deferred Disposition by the due date established by the court, my case will be dismissed. If I do not complete the terms of the Deferred Disposition, I will be sent a notice to appear in court to show cause why I did not complete the terms of this deferral. If cause is not sufficient, I understand that the Deferred Disposition will be revoked and I will be found guilty of the offense.

I understand that the deferral period is **90 days** from the date this form is postmarked and agree to the terms of the Deferred Disposition, which are:

1. The payment must be made immediately:
  - a. For your first request for deferred disposition in Austin, \$144.00 plus collection and/or warrant fees, if applicable. If the violation date is on or before **31 December 2019**, submit \$133.00 plus collection and/or warrant fees, if applicable.
  - b. For a second or subsequent request, an amount equal to the current balance of the case which is \$ \_\_\_\_\_ (you cannot pay online and must send a check or money order with this request; contact the court if you cannot pay immediately); **and**
2. Complete the three (3) hour online Defensive Cycling course through the Center for Cycling Education (register at [www.thecce.org/dc-austin](http://www.thecce.org/dc-austin)) . **For this course, the certification is emailed directly to the court once complete.** You may also complete a six (6) hour Driving Safety Course approved by the Texas Department of Licensing and Regulation, but must submit to the Court a copy of the certification of completion by the end of the deferral period which is 90 days from the date this request is postmarked. The copy may be submitted in person, by fax, by mail or via email; and
3. Commit no like offenses within the city limits of Austin, Texas during the deferral period.
