NOTICE OF PROPOSED RULE

POSTING DATE: January 6, 2015

The Director of the Planning and Development Review Department proposes to adopt the following rule after February 7, 2015.

Comments on the proposed rule are requested from the public. Comments should be submitted to Sylvia Arzola, Planning and Development Review Department, 505 Barton Springs Road, Suite 500; 512-974-6448. To be considered, comments must be submitted before February 7, 2015, the 32nd day after the date this notice is posted. A summary of the written comments received will be included in the notice of rule adoption that must be posted for the rule to become effective.

An affordability impact statement regarding the proposed rule has been obtained and is available for inspection or copying at the address noted in the preceding paragraph.

EFFECTIVE DATE OF PROPOSED RULE

A rule proposed in this notice may not become effective before the effective date established by a separate notice of rule adoption. A notice of rule adoption may not be posted before February 7, 2015 (the 32nd day after the date of this notice) or not after April 6, 2015 (the 90th day after the date of this notice).

If a proposed rule is not adopted on or before April 6, 2015, it is automatically withdrawn and cannot be adopted without first posting a new notice of a proposed rule.

R161-15.02: Delete and replace the current Residential Permit Application and replace it with the following applications. The current application is a single form used for all

project types. The purpose of the proposed rule adoption is to create separate and distinct forms for different project types.

- Exhibit G: Residential Volume Builder Program Building Permit Application

AUTHORITY FOR ADOPTION OF PROPOSED RULE

The authority and procedure for adoption of a rule to assist in the implementation, administration, or enforcement of a provision of the City Code is provided in Chapter 1-2 of the City Code. The authority to regulate residential building requirements is established in Title 25 of the City Code.
