THE VORTEX/BUTTERFLY BAR – Business Overview:

- Performing arts venue (VORTEX Repertory Co.)
- Bar (Butterfly Bar)
- Food truck (Patrizi's)
- Produces 10 original productions annually
- Earns on average \$60,000 in bar revenue monthly
- Serves about 10,500 meals weekly

COMPOSTING HIGHLIGHTS:

- » Decreased weekly landfill trash capacity by 60% via composting
- » Saving \$600/year in trash hauling services
- » Using only compostable material at bar and food truck

- » Providing straws upon request
- » 80% reduction in straw usage
- » Saving more than \$500/year on straw purchases, after switching to compostable straws

Challenges. As a nonprofit organization, The VORTEX struggled to fund a composting program. The Zero Waste Business Rebate enabled management to jump-start a program for both employees and customers.

Solutions. The VORTEX/Butterfly Bar contacted Austin Resource Recovery's (ARR) Business Outreach Team for a free Zero Waste Assessment. ARR suggested the following actions to reduce waste:

- Start a commercial composting service
- Create collection stations for composting and recycling
- Provide straws upon request only
- Switch to all compostable or recyclable materials
- Require employee training on recycling and composting

Results. The VORTEX/Butterfly Bar held a kick off compost party featuring a themed drink to inform customers about composting and the new compostable materials at the bar and food truck. Changes resulted in:

- Decreased straw use by 80% (10,000 less straws/month)
- Reduced labor costs for daily clean ups
- Increased cleanliness of dumpster area and elimination of compost odors
- Implemented customer education at the bar
- Removed all landfill trash containers, except one

Success Factors. By adding compost collection, The VORTEX/Butterfly Bar cut weekly landfill trash service capacity by 60 percent. Bundling waste services (landfill trash, recycling and compost) to one hauler reduced costs and simplified billing processes. Easy-to-read signage and persistent education of staff and customers reduced contamination.

Looking Forward. The VORTEX/Butterfly Bar regularly monitors their trash volumes, looking for opportunities to decrease trash service. Currently, the business is searching for a way to dispose of materials from theater set breakdowns, when materials reach the end of their life (e.g. treated wood scraps, painted fabric).
