- \* Check the box next to the Acknowledgment Statement and sign the application. The application MUST be signed by all owners listed on the Appraisal District's Records and the owner's agent, if applicable. Original signature required.
- \* Execute a Check or Money Order in the amount of \$443 which includes the \$393 Licensing Fee and the \$50 one-time Notification Fee, payable to the "CITY of AUSTIN". The application fee is non-refundable.
- \* MAIL via USPS Certified Mail/Return Receipt Requested the Short-Term Rental Application with the required supporting documentation and licensing fee to:
