## ALTERNATE PERSONAL NET WORTH (PNW) DOCUMENTATION INSTRUCTIONS:

The terms "Minority-Owned Business Enterprise (MBE)" and "Women-Owned Business Enterprise (WBE)" now incorporate economic disadvantage into their definitions, and the term "economic disadvantage" is defined as a personal net worth figure equal to or less than a specified dollar amount.\* The City chooses to use a Personal Net Worth Statement (PNW) to collect the necessary financial information to meet this requirement.

To determine a firm's eligibility, a PNW Statement is required from:

- 1. Each socially disadvantaged proprietor, or
- 2. Each socially disadvantaged limited and general partner whose combined interest totals 51% or more, or
- 3. Each socially disadvantaged stockholder owning 51% or more of voting stock.

For 2018 the term "economic disadvantage" is defined as a personal net worth figure equal to or less than \$1,511,000.

In lieu of submitting the PNW Statement directly to the City of Austin, applicants and certified firms seeking recertification may submit the following documentation to the City:

- Completed Sworn Statement of Alternate PNW Verification by the applicant or MBE/WBE owner
  indicating that all information required on the PNW Statement has been provided to a Texas
  Certified Public Accountant (CPA), which may be subject to review by representatives of the
  City of Austin; and
- Completed Sworn Statement of Alternate PNW Verification by the CPA verifying that the personal net worth of the applicant or MBE/WBE owner(s) is equal to or less than \$1,511,000.
