City of Austin DBE Program

What is the DBE Program?

- •The U.S. Department of Transportation's Disadvantaged Business Enterprise (DBE) program provides a vehicle for increasing the participation of women and minorities in state and local procurement.
- •Federal Regulations require recipients that receive USDOT financial assistance to establish a DBE Program for the participation of DBE's.
- •Recipients are required to establish annual DBE goals and review contracts throughout the year to establish project-specific DBE subcontracting goals.

Who must have a DBE Program?

- All FHWA primary recipients receiving funds
- FTA recipients receiving planning, capital and/or operating assistance who will award prime contracts (excluding transit vehicle purchases) the cumulative total value of which exceeds \$250,000 in FTA funds in a Federal fiscal year;
- FAA recipients receiving grants for airport planning or development who will award prime contracts the cumulative total value of which exceeds \$250,000 in FAA funds in a Federal fiscal year.
- The majority of City of Austin procurements are FAA DOT-assisted contracts.

DBE Program Objectives

It is the policy of the City to ensure that DBEs as defined in Part 26, have an equal opportunity to receive and participate in DOT–assisted contracts. It is also our policy:

- 1. To ensure nondiscrimination in the award and administration of DOT- assisted contracts;
- 2. To create a level playing field on which DBEs can compete fairly for DOT-assisted contracts;
- 3. To ensure that the DBE Program is narrowly tailored in accordance with applicable law;
- 4. To ensure that only firms that fully meet 49 CFR Part 26 eligibility standards are permitted to participate as DBEs;
- 5. To help remove barriers to the participation of DBEs in DOT assisted contracts;
- 6. To promote the use of DBEs in all types of federally-assisted contracts and procurement activities;
- 7. To assist the development of firms that can compete successfully in the market place outside the DBE Program; and
- 8. To provide appropriate flexibility to recipients of Federal financial assistance in establishing and providing opportunities for DBEs.


Certification

DBE Certification Requirements

- <u>51 percent owned</u>, <u>managed</u> and <u>controlled</u> by an economically and socially disadvantaged individual
- Must be U.S. citizen or Legally Admitted Resident
- Contributions, ownership, and daily management control clearly documented
- Presumed Groups: Asian-American; African-American; Native American; Hispanic; Women
- The primary economically disadvantaged owner(s) personal net worth not to exceed \$1.457 million
- Firm must be organized as a for-profit business
- On-site visit required

Compliance

Compliance Requirement

- City of Austin monitors DBE participation on all prime and sub contracts
- Contractors/Consultants identify DBE subcontractors that they are intending to use to meet DBE contract goal
- Contractors/Consultants submit monthly reports on DBE participation
- City of Austin staff verify that DBE subcontracts are in compliance with federal program requirements
- City of Austin identifies any corrective actions for compliance issues

DBE Proposed Program

Goal Methodology Race Conscious/Race Neutral (RN/RC)

The Overall Goal and the breakdown for specific Race Conscious and Race Neutral Goals (both of which include gender-conscious/neutral goals) is reported.

- The Race Conscious Goal is based on measures that provide benefits only for DBEs. The use of contract goals is a primary example of a race conscious measure.
- The Race Neutral Goal include measures for all firms while benefiting DBEs.

DBE Goal Calculation

It's a Two Step Process!

- Step 1 Determine the base figure for the relative availability of DBEs.
 Availability refers to ready, willing and able (RWA) firms.
- Step 2 Examine available evidence to determine adjusting base figure.

Step 2b Examination of available evidence to determine adjusting base figure using past participation

Fiscal Year	Goal	Accomplishment
2011	28.56%	11.91%
2012	28.56%	9.80%
2013	28.56%	7.19%
2014	9.60%	12.30%
2015	9.60%	10.89%

Arranging this historical data from low to high, (7.19%, 9.80%, 10.89%, 11.91%, 12.30%) the median is 10.89%.

The proposed Overall DBE Goals are as follows:

Fiscal Year #1 - 15.81% (20.74% + 10.89%)/2)

Fiscal Year #2 - 15.76% (20.63% + 10.89%)/2)

Fiscal Year #3 - 15.76% (20.63% + 10.89%)/2)

Average of the three years 15.81+15.76+15.76 = 47.34/3 = 15.77%

Recommended DBE Goal

Based on the information and evidence currently available, City of Austin is recommending a DBE Goal of 15.77% (Estimate)


