



## COMMERCIAL KITCHEN INDUSTRIAL / COMMERCIAL / INSTITUTIONAL REBATE

Austin Water's **Commercial Kitchen Rebate** helps Industrial, Commercial and Institutional customers with costs for replacing food service equipment with more water-efficient models.

### WATER SAVINGS

- Water-efficient equipment upgrades may help to lower water, wastewater, and energy bills.

### REBATE AMOUNT

- **From \$40 to \$5,000** for each item of eligible equipment installed (*see application for list*)
- Equipment may also be eligible for [Austin Energy](#) and [Texas Gas Service](#) rebates

### ELIGIBILITY

- **Applicant:**
  - o Must be an Austin Water Industrial, Commercial, or Institutional (ICI) customer
  - o Must be the property owner or utility account holder
  - o Willing to take part in a survey about the equipment to access program effectiveness
- **Water-Efficient Kitchen Equipment:**
  - o May be either purchased or leased
  - o Must remain in use for at least five years after installation or be replaced with an equipment/process that saves as much or more water
    - Replacement equipment/process must remain in use for the remaining balance of the five-year period or the applicant must refund a prorated amount of the rebate based on the actual time the equipment was used
  - o For other equipment/process upgrades, use the [Bucks for Business Rebate](#)

### CHECKLIST

- Meet all eligibility requirements
- Submit application **within 30 days** of equipment purchase/lease agreement and include:
  - Itemized purchase receipts/lease agreements with the manufacturer and serial number for each item of equipment installed/leased
  - Documents showing names/addresses of responsible parties and proof of at least a five year lease term (*for leased equipment only*)
  - Completed [IRS Form W-9](#)
