



LANDSCAPE SURVIVAL TOOLS RESIDENTIAL REBATE

Austin Water's **Landscape Survival Tools Rebate** for mulch, compost, and core aeration can help keep your yard healthy while saving water.

SAVINGS

- Can cut down your irrigation run times by half or reduce your need for hose-end irrigation.

REBATE AMOUNT

- **\$50** for at least 2 cubic yards (54 cubic feet) of compost (*[DilloDirt™](#) is acceptable*)
- **\$40** for at least 2 cubic yards (54 cubic feet) of mulch
- **\$30** for core aeration service of entire front and/or back lawn
- Rebate amount may not exceed total amount of eligible project costs

ELIGIBILITY

- Be a residential customer of Austin Water or a [qualifying water provider](#)
- Ordered or purchased materials / services on or after February 15, 2020 and not later than June 15, 2020
 - o Materials purchased from fundraising events are not eligible
- Have not already received this rebate or the Drought Survival Tools for Your Yard Rebate at this property address in the past two seasons (Spring 2019 & Spring 2018)
- Only one application accepted per calendar year

CHECKLIST

- ☐ Meet all eligibility requirements above
- ☐ Agree to reduce irrigation by adjusting your automatic irrigation run times based on Austin Water's [irrigation calculator](#) or shortening the time you use your hose-end sprinkler
- ☐ Submit the application no later than June 15, 2020, and include:
 - ☐ **Itemized and dated paid-in-full receipts/invoices** with vendor contact information
 - ☐ **Photos** showing final installation of each applicable Landscape Tool
 - ☐ Send application, receipts and photos to:
