INDUSTRIAL WASTE-BUILDING PLAN REVIEWS

Industrial Waste (IW, Austin's Pretreatment Program) reviews building plans for compliance with pretreatment regulations and provides approval letters for pretreatment devices and systems that meet our requirements.

IW approval is required prior to new construction or any plumbing or process change that alters the quality or quantity of industrial wastewater discharged to the City's sewer system.

Please do not refer to this document for Site Plan reviews.

The following projects need to be routed to IW for Building Plan Review:

- Doctor's Offices

 Hair related Businesses, such as Dog Washes, Bet Groc
- Parking Garages
- Hair-related Businesses, such as Dog Washes, Pet Grooming, Hair Salons and Veterinary Clinics
- Multi-family Apartment Complexes and other strictly-residential projects
