- Identify the City of Austin Standard and/or Standard Specification that governs the product.

- Provide copies of all applicable AWWA, ASTM, ASNI, NFPA, or other related standards or specifications that govern the product.
- Provide evidence of NSF registration for products to be used in a potable water system.
- Provide test results showing compliance with applicable standards, including independent laboratory test results, as necessary.

- List maintenance requirements, special equipment and procedures and recommended maintenance schedules.
- List project owners (public utilities preferred) who have used the product. Include project name and location, project owner's contact name, address, and telephone number, and product application and number of years in use.
- Provide material safety data sheet (MSDS), if applicable.
- Describe recent product revisions or improvements.
- Explain how the product would benefit the Austin Water Utility in terms of prolonged service life, reduced maintenance, and reduced life-cycle cost compared to products now in use.
- Include quality control program covering the manufacturing of the product. If manufacturer is ISO registered, just submit evidence of registration.
