




Project Timeline

- Previous flooding in 1998, 2001, 2013
- 2006 Report
- Buyouts (Bayton Loop, Phase 1)
- Phase 2 of Flood Risk Reduction Project
 - Develop current flood risk maps (new rain data)
 - Evaluate viability of previously identified alternatives
 - Provide recommendation of viable alternatives to further investigate in Preliminary Engineering Study









Alternative 1– Optional Buyouts

- Could address all flooding risk (assuming full participation)
- **Cost**: \$20 million to more than \$250 million, depending on the number of structures. (prepandemic estimate)
- **Timeline**: 2 to 5 years, once funding is secured
- Eligibility to be determined















Alternative 2– Creek Modifications

- Effective, but not all structures would be removed from floodplain
- Environmental impact compared to buyouts and tunnel options
- Needs additional refinement
- **Cost**: \$60 to more than \$100 million (prepandemic estimate)
- **Timeline**: 5 to 7 years, once funding is secured.


















Alternative 3 Bypass Tunnel

- 2.4-mile bypass tunnel from West Gate Blvd to South Congress Ave. underneath Stassney Ln.
- Structural alternative with the most number of structures removed (number)
- **Cost**: More than \$230 million (pre-pandemic estimate)
- Timeline: 7 to 10 years, once funding is secured







- Those at highest risk believe even more strongly in the need for a project






Have you ever considered moving because of flooding?



- Very few residents found that none of the alternatives were acceptable



Only structures that have already experienced repetitive flooding

 Residents are more likely to favor including those homes that have flooded or are at higher risk.



- An equally large number is not sure about what their decision would be



To help reduce the flood risks at houses, is it acceptable to remove large trees?



NEXT STEPS

- Incorporate survey results into feasibility study
- Finalize Feasibility Report (Spring 2022)
- Preliminary Engineering Phase (Starting Fall 2022)
- If applicable, select an alternative (2024)
- Determine potential funding sources
- Design and/or implement selected alternative




