<p>Restaurants for consumption off-premises</p>	<p>In-house dining – not permitted</p> <p>Drive-through, drive-in, take-away, and delivery – permitted</p> <ul style="list-style-type: none"> • Practice social distancing – sufficient space for all people to be 6 feet apart at all times.
<p>Essential business, including:</p> <p>Healthcare operations</p> <p>Stores selling groceries and other essential supplies</p> <p>Food cultivation</p> <p>Social services and charitable organizations</p> <p>News media</p> <p>Gas stations and businesses needed for transportation</p> <p>Financial institutions</p>	<p>Strongly encouraged to remain open</p> <p>Practice social distancing – sufficient space for six feet from other individuals</p>

<p>Hardware and supply stores Critical trades (plumbers, electricians, exterminators, and other service providers for essential operation of residences and essential entities) Mail and delivery services Laundry services Supplies to work from home Supplies for essential businesses, critical infrastructure, and essential government functions Food delivery services Transportation Home-based care and services Residential facilities and shelters Professional services (legal, accounting, insurance, and real estate services to assist in compliance with legally mandated activities) Information technology services Moving supply services Hotels and motels Funeral services</p>	
<p>Childcare facilities which provide services to enable parents to continue working in essential businesses</p>	<p>To the extent possible, must operate under the following mandatory conditions:</p> <ul style="list-style-type: none"> • Carried out in stable groups of 10 or fewer (same group each day) • Children shall not change from one group to another • If more than one group present, each group shall be in a separate room and groups shall not mix • Childcare providers shall remain solely with one group
<p>Educational institutions, including public and private K-12 schools, colleges, and universities</p>	<p>Open, provided social distancing is maintained, only for:</p> <ul style="list-style-type: none"> • Facilitating distance learning • minimum necessary activities to maintain the value of the business’s inventory, ensure security, process payroll and employee benefits, or for related functions • minimum necessary activities to facilitate employees of the business being able to continue to work remotely from their residences • Providing food to students or members of the public on a pick-up or take-away
