## Older Adults

#### POSSIBLE RESOURCES & ACTIVITIES

- Day care
- Service navigation assistance accessing health care, insurance, basic needs assistance, etc.
- Exercise outdoor exercise area, walking & biking
- Art, music, gardening
- Cooking, nutrition activities
- Group trips to HEB, field trips to other locations
- Health screenings
- Tele-behavioral health
- Interactions with children under age 5, middle schoolers, and/or college/graduate students

#### **CONSIDERATIONS**

- Will the program serve older adults of all abilities? Will the center be equipped to handle older adult care needs that may arise?
  - Adults with memory issues
  - Toileting needs
- ADA compliant for older adults with accessibility for indoor & outdoor areas
- Level of interest in intergenerational interactions
  - Interest in interactions with younger people of different ages
- Regular participants vs. drop-in participants
- Background checks



# Child care for children under age 5

#### PLAN FOR PROGRAM

- Licensed child care program that meets state regulation minimum standards
- High-quality child care program (nationally accredited and Texas Rising Star four-star rated)
- Accepts child care scholarships (i.e. subsidies)
- Indoor and outdoor classroom/play areas
- Indoor & outdoor areas to be fully accessible for children of diverse abilities

#### **CONSIDERATIONS**

- Financial viability & sustainability of operating child care program
  - Number of classrooms, number of children
  - Indoor & outdoor square footage needed
  - Ages served, availability of free public Pre-K nearby
  - Focus on low-income, including infants & toddlers, may require ongoing financial support for operations
- Safety
  - Intergenerational activities always supervised by child care staff
  - IRAC open to the public
  - Background checks for older adults & students at program regularly
  - Occasional & drop-in visitors
  - Parent comfort



# Intergenerational Programming

#### Age Groups

- Older adults
- Children under age 5
- Middle schoolers
- UT students

#### Intergenerational Curriculum & Activities

- Specially designed intergenerational curriculum
- Art, gardening, music, cooking, visit food forest, field trips, reading buddies, pen pals
- Older adults mentor or tutor middle schoolers
- Middle schoolers interview older adults

## Various possibilities for intergenerational interactions

- Older adults Young children
- Older adults Middle schoolers
- Young children Middle schoolers
- Young children, middle schoolers, & older adults
- Etc.

### Key Consideration – Evaluation of the center & curriculum

- UT graduate students
- Observations, surveys, focus groups
- Consent from adult participants and parents of minor participants
